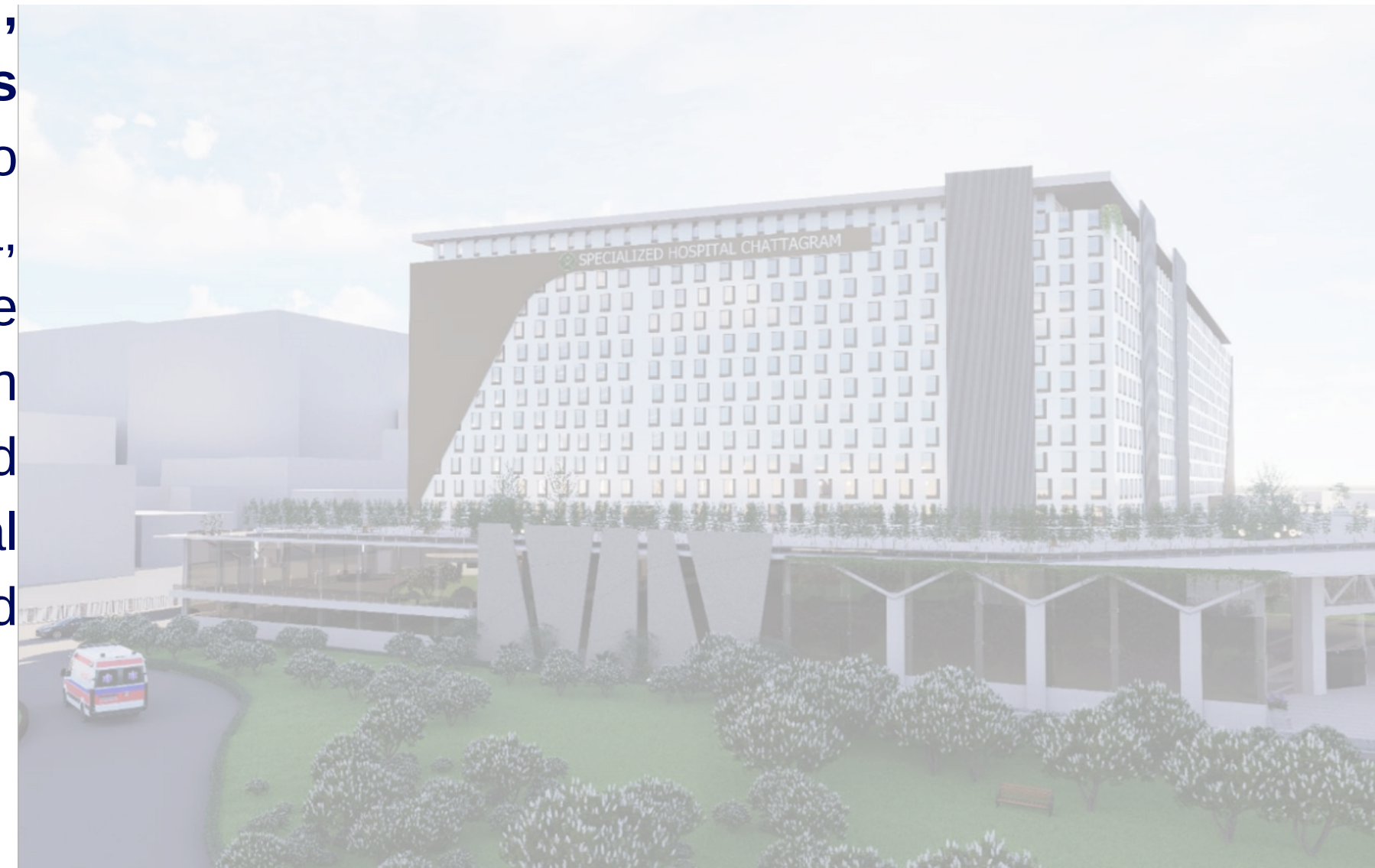
Commodity Trading
